**Implementation date and any proposed stages for implementation:**

2. The date on which the proposal is planned to be implemented, and if to be implemented in stages, a description of what is planned for each stage, and the number of stages intended and the dates of each stage.

**It is proposed to increase the capacity at Lambley Primary School (“the School”) by increasing the number of pupils to be accommodated from 157 to 210 in Years Reception to Year 6 (ages 4 to 11) from 1 September 2019.**

**It is proposed that the expansion would be phased in four stages with the School taking up to 30 Reception pupils from 1 September 2019 and in subsequent years. There would be an in-year variation for September 2019 in order to allow up to 30 pupils to be admitted in 2019/20 and in subsequent years the Published Admission Number (PAN) for the School would be 30. In the school year 2019/20, the School would take up to 30 pupils in Years 1, 2 and 3. The School would retain an admission number of 22 in Years 4, 5 and 6. It is proposed that these three year groups will retain their admission number of 22 until each relevant year group has finished Year 6. This phased expansion would allow the School to manage the expansion carefully, giving due regard to the class organisation of those pupils already attending the School**

**If the proposal to increase the capacity of the School is implemented, the year 3 group’s admission number of 30 pupils will reach Year 6 in 2022. If 30 pupils were to be admitted to all year groups, then the School would be at its maximum capacity of 210 in 2022.**

**NCC proposes to make a prescribed alteration to Lambley Primary School by expanding the school's current net capacity from 157 permanent places to 210 from September 2019.**

- (b) Details of the current number of pupils admitted to the school in each relevant age group, and where this number is to change, the proposed number of pupils to be admitted in each relevant age group in the first school year in which the proposals will have been implemented.

**At the time of publication, there were 146 full-time equivalent pupils on roll at the school.**

**Objectives:**

7. The objectives of the proposal.

**The area served by Lambley Primary School has a growing population due to increased house building. The School's accommodation is sufficient for the current PAN of 22 but does not meet the needs of a growing population. Adding an extra room would provide the School with seven classrooms which would then support a PAN of 30. By phasing the expansion, the School would be able to efficiently oversee the growing numbers of children attending whilst maintaining the good standard of education already provided. It would also enable the School to manage its resources efficiently.**

**There is a demand for places at the school. It is a Good school according to its latest Ofsted inspection report, conducted in January 2018. Expanding the school would increase the provision of places at good schools in the area and increase the choices available to parents. For those families moving into new homes in the area, there would be more local availability, reducing the need to attend schools some distance away from their community. This would contribute to improved attendance, family wellbeing and local cohesion.**

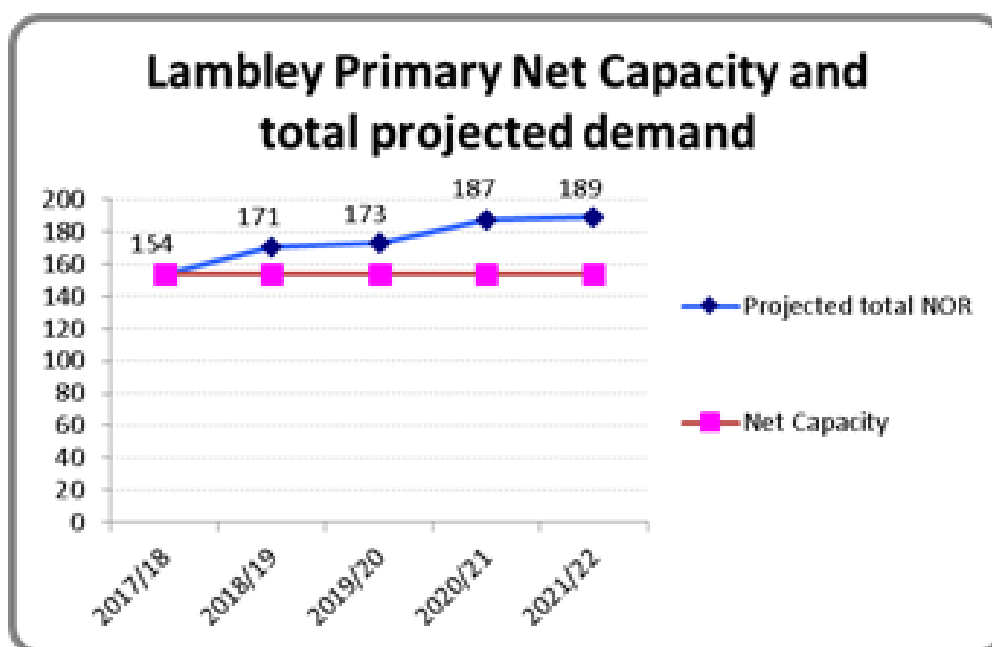
## Evidence of Demand:

### 8. Evidence of demand for the additional school places.

In line with the underlying national trend, Nottinghamshire has seen an increase in the overall school population, particularly in the numbers of primary age children.

The total primary Number on Roll (NOR) has seen an increase over the past few years which causes difficulties for parents moving into an area where there are no places at their local (catchment area) school.

The area served by Lambley Primary School has a growing population due in part to an increase in house building. The number of primary school aged children in this area is forecast to continue to rise over the next few years, including in the village of Lambley This can be seen in the chart below:



The numbers of primary aged pupils have increased across Lambley village and the expansion of Lambley Primary is required to meet an increasing basic need for pupil places within the school's area.

Without the places being made available at Lambley Primary, the County Council will not be able to offer school places for all children living in the area within a reasonable distance to their homes.

## Effect of Proposal:
