Proposed Parking Restrictions (TRO 1242)

BASSETLAW HOSPITAL AREA, WORKSOP – PUBLIC ADVERT

The consultation for this scheme was originally advertised in March 2020. The consultation was stopped due to the restrictions imposed by the coronavirus measures which meant that the consultation documents could not be viewed at the local library or County Hall. The Government has since relaxed the requirement to have the documents on deposit. The documents can now be viewed on either the Nottinghamshire County Council website or they can be sent to you by post or e-mail on request.

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services. It is proposed that double yellow lines (No Waiting at Any Time) be installed at the following locations: -

- Junction of Wingfield Ave / Carlton Road
- Junction of Prospect Precinct / Gloucester Road
- Entrance to the shopping precinct car park off Gloucester Road
- Junction of Wingfield Ave / Ravenscourt
- Junction of Wingfield Ave / Primrose Way
- Wingfield Avenue, on the bend near Greenacres Grange
- Blyth Road, outside No 78
- Blyth Road, opposite No 67
- Blyth Road, opposite the junction of Westfield Drive

Also, double yellow lines (No Waiting at Any Time) and single yellow lines (11am – 1pm, Monday to Friday) on Inglemere Close, Wessex Road and the Westfield Drive area including Hillcrest Crescent and part of Lindrick Close.

These parking restrictions are required to address issues with obstructive parking which is restricting visibility, access to properties and impeding the movement of vehicles at these locations. The proposals will be advertised, and notices displayed on site. Plans showing the proposals (drawing numbers H/GC3348/01-4) are attached, along with a copy of the site notice.
