

## THE NOTTINGHAMSHIRE COUNTY COUNCIL (BATH LANE, MANSFIELD) (PROHIBITION OF WAITING AND PARKING PLACES) TRAFFIC REGULATION ORDER 2023 (2255)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Mansfield in the District of Mansfield: -

1. Proposed prohibition of **Waiting At Any Time** (double yellow lines) along the following lengths of road: -

## Bath Lane, Mansfield (the north-west side)

- (i) from a point 69 metres north-east of a point opposite the north-eastern kerb line of Rock Valley in a north-easterly direction to a point 100 metres north-east of its junction with Shirburn Avenue.
- 2. Proposed **parking bay for up to 3 hours** on Monday to Saturday on 8am to 6pm along the following lengths of road:-

## Bath Lane, Mansfield (the north-west side)

- (i) from a point 100 metres north-east of its junction with Shirburn Avenue in a north-easterly direction for a distance of 29 metres.
- (ii) from a point 139 metres north-east of its junction with Shirburn Avenue in a north-easterly direction for a distance of 74 metres.

The works are associated with the new development on the southern side of Bath Lane.
