## BEACON HILL ROAD, NEWARK – PROPOSED RESIDENTS' PARKING SCHEME (MON – SAT, 8AM – 7.30PM) PUBLIC CONSULTATION – TRO 3366

Via East Midlands is working on behalf of Nottinghamshire County Council to deliver highway services.

Nottinghamshire County Council have received requests to consider implementing a parking scheme to remove long-term non-residential parking from Beacon Hill Road. In December 2022 a questionnaire was sent to all affected residents to assess the level of support for a residents' parking scheme on Beacon Hill Road between its junction with The Gateway and Wellington Road. The questionnaires were sent to 56 residents of which 21 (38%) replied, of the responses 15 (71%) were in favour of the introduction of a residents' parking scheme. These results meet the criteria for the scheme to proceed to the formal consultation stage. The proposal is to introduce a residents parking scheme that would be operation on Monday to Saturday between 8am and 7.30pm when a permit would be required to park on street. The existing double yellow lines would still prohibit waiting by all vehicles at all times.

The extents of the proposal are shown on the enclosed drawing (H/JAB/4162/100) and notice.

Before proceeding further, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. Any observations on these proposals should reach me in writing, either by letter or email, by **6<sup>th</sup> March 2023**. If your comments are in the form of an objection to the proposals please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.

The residents of the properties facing onto Beacon Hill Road, between The Gateway and Wellington Road, would be eligible to buy parking permits to park on Beacon Hill Road during the times the scheme is in operation.

The introduction of a residents' parking scheme would allow those residents and their visitors to continue parking on street; when displaying a valid permit. However, a permit would not guarantee a space directly outside a person's property and at busy times may not guarantee a space within the boundaries of the scheme.
