INSTALLATION OF RAMPED PARALLEL CYCLE CROSSING & ZEBRA CROSSING BECKSIDE, GAMSTON

PUBLIC CONSULTATION

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council is proposing to install a humped parallel cycle and zebra crossing across Beckside, Gamston.

The proposed ramped zebra and parallel (cycle) crossing will be located on Beckside approximately 54 metres east of its junction with Coledale. It is being installed to assist pedestrians crossing Beckside, pedestrians traveling to the nearby, primary school, shopping facilities and Lings Bar Hospital.

The crossing will have a controlled area, indicated by zig-zag markings, along the carriageway where parking and loading will be prohibited. The effects of the road hump will be a single 75mm high, 10.5m long (including approach ramps), flat-topped road hump (plateau).

The location of the proposed crossing is shown on the attached plan, TP2150257/002.

As required under Section 23 of the Road Traffic Regulation Act 1984 (parallel cycle and zebra crossing) and Section 90A - 90I of the Highways Act 1980 (traffic calming hump), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the parallel cycle and zebra crossing crossing and road hump on Beckside, Gamston.


