**BERRY HILL LANE, MANSFIELD - PROPOSED RAISED PUFFIN CROSSING - PUBLIC ADVERT**

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. Nottinghamshire County Council have received requests to install a Raised Puffin Crossing on Berry Hill Lane, Mansfield, immediately west of Black Scotch Lane. The raised crossing will be located on a 9.2m long, 75mm high flat-topped hump (plateau). The proposed Raised Puffin Crossing aims to improve pedestrian safety, especially for school children on their way to and from Berry Hill Primary School.

It is therefore proposed to install a Raised Puffin Crossing, which will have a controlled area, indicated by zig-zag markings, along the carriageway where parking and loading will be prohibited.

As required under Section 23 of the Road Traffic Regulation Act 1984 (puffin crossing with raised plateau), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the raised puffin crossing on Berry Hill Lane, Mansfield.

Further to the initial consultation letter of the 3<sup>rd</sup> December 2024, the next stage of the consultation is to publicly advertise the scheme. The advert will be published in the Mansfield and Ashfield Chad and notices will be fixed on site. A plan showing the extents of the 'No Stopping or No Loading At Any Time' restrictions (Zig-Zag lines) is attached (Drawing Number 2450356-VIA-HGN-ZZ-PL-CH-00001) along with a copy of the site notice.

Any objections should clearly state the reasons for the objections and should reach us in writing, either by letter or email, by **5<sup>th</sup> February 2025**. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
