<u>NOTTINGHAM ROAD, NUTHALL - BUS STOP BR 0471 - RELOCATION AND CLEARWAY</u> <u>NO STOPPING, AT ANY TIME, EXCEPT BUSES</u>

Via East Midlands is working on behalf of Nottinghamshire County Council. As part of a new bus lane being constructed on the A610, which will provide bus priority for outbound buses through Nuthall, it is necessary to move the existing bus stop BR0471 on the A610 to a new location on Nottingham Road. The new bus stop will have a new bus stop clearway, raised boarding kerbs, bus shelter, real time information display and litter bin.

As part of Nottinghamshire County Council's on-going commitment to improve public transport in the County, it is proposed that the existing Bus Stop will be removed and relocated to the new location stated below, and will be formalised as an enforceable marked bus stop clearway as shown on the attached site notice: -

No Stopping At Any Time, except buses

• Nottingham Road, Nuthall (BR 0471) – in lay-by opposite The Nuthall

The clearway will prohibit all vehicles except buses from parking or waiting At Any Time in the bus stop area and will be clearly identified with new road markings and signage. As a result, the bus stop will be accessible for buses serving that stop during these times. In addition, it is proposed to install a new Real Time Pole and raised Bus Stop kerbs at the new location.

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the location listed above, a new bus stop clearway is to be installed that prohibit other vehicles from parking or waiting in the bus stop at the times specified and will be clearly identified with new road markings and signage. The main benefits of bus stop clearways are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users.
- Ease congestion as a correctly aligned bus will not block the road for other road users.
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road.
- Ensure that bus services operate on time and are not unnecessarily delayed.
