## BRECK HILL ROAD/WOODBOROUGH ROAD, MAPPERLEY - PROPOSED NEW BUS STOP CLEARWAY OPERATING HOURS - FORMAL ADVERT

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire.

Further to the initial consultation letter of 1<sup>st</sup> November 2024, the next stage of the consultation is to publicly advertise the scheme. Notices will be fixed on site, containing the proposed advert plan. A drawing showing the proposed new clearway operating hours and the relocation of the bus stop pole and shelter at GE0051 (*Drawing Number H/FR/4799/01*) is attached along with a copy of the Site Notice.

## No Stopping At Any Time, Except Buses at Existing Clearway:

- Woodborough Road, GE0551
- Woodborough Road, GE0550

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the locations listed above, bus stop clearways are to be installed that prohibit other vehicles from parking or waiting in the bus stop at any time and these will be clearly identified with new road markings and signage. The main benefits of bus stop clearways are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

Any observations on these proposals should reach me in writing, either by letter or email, by the **30<sup>th</sup> December 2024**. If your comments are in the form of an objection to the proposals, please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
