

THE NOTTINGHAMSHIRE COUNTY COUNCIL (BROOMHILL LANE AREA, MANSFIELD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (2290)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Mansfield in the District of Mansfield: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

BROOMHILL LANE, (MANSFIELD) (the north-east side)

• From a point 10 metres south-east of its junction with Dahlia Street, in a north-westerly direction to a point 10 metres north-west of that junction.

DAHLIA STREET, (MANSFIELD) (the east side)

From its junction with Broomhill Lane in a northerly direction for 10 metres.

DAHLIA STREET, (MANSFIELD) (the west side)

• From its junction with Broomhill Lane in a north-easterly direction for 10 metres.

<u>PEACE HAVEN CRESCENT, (MANSFIELD)</u> (the north-west junction with Broomhill Lane) (the north-west side)

From its junction with Broomhill Lane, in a north-easterly direction for 10 metres.

<u>PEACE HAVEN CRESCENT, (MANSFIELD)</u> (the north-west junction with Broomhill Lane) (the south-east side)

• From its junction with Broomhill Lane, in a north-easterly direction for 10 metres.
