

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (BUCKFAST WAY, WEST BRIDGFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8407)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at West Bridgford in the area of Rushcliffe -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

## **Buckfast Way** (north-east side)

• From a point 19 metres west of its junction with Newstead Drive in a westerly direction for 46 metres

# **Buckfast Way Turning Circle** (both sides)

- For its full extent.
- Proposed Bus Stop Clearway No Stopping At Any Time except buses along the following length of road: -

### **Buckfast Way Turning Circle** (north side)

• From a point 3 metres north-west of its junction with Buckfast Way (Exit from turning circle) in a north-westerly direction for 15 metres.
