**GEDLING AREA BUS STOP CLEARWAYS –  
HOMEFIELD AVENUE AND BIRCHFIELD ROAD, ARNOLD  
BUS STOP CLEARWAYS – NO STOPPING, EXCEPT BUSES, AT ALL TIMES.**

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce new bus stop clearways on Homefield Avenue and Birchfield Road, Arnold. The new bus stop clearways will be no stopping, except buses, at all times. The bus stop locations are listed below:-

- Bus Stop GE0463 – O/S No.s 37 and 39, Homefield Avenue
- Bus Stop GE0373 – O/S No.s 109 to 113, Birchfield Road
- Bus Stop GE0359 – O/S No.s 62 to 66, Birchfield Road

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from indiscriminate parking. At the locations listed above, bus stop clearways are to be installed that prohibit other vehicles from parking or waiting in the bus stop at all times and these will be clearly identified with new road markings and signage. The main benefits of bus stop clearways are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

Before proceeding further with the bus stop clearways, I wish to consider the views of residents and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me by **26th November 2018**.
