

The Nottinghamshire County Council (Carlingford Road, Linby Walk and St Mary's Way, Hucknall) (Prohibition of Waiting and No Stopping on Entrance Clearways) Traffic Regulation Order 2018 (4210)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Hucknall in the District of Ashfield:-

Vehicles will be prohibited from waiting at any time along the following: -

CARLINGFORD ROAD (HUCKNALL) (the east side)

from its junction with Linby Walk in a southerly direction for 8 metres

CARLINGFORD ROAD (HUCKNALL) (the north side)

• from a point 8 metres south of its junction with Linby Walk in an easterly direction for 9 metres

<u>CARLINGFORD ROAD (HUCKNALL)</u> (the south side)

• from a point 26 metres south-west of its junction with St Mary's Way in an easterly direction for 5 metres.

CARLINGFORD ROAD (HUCKNALL) (the west side)

• from a point 31 metres south-west of its junction with St Mary's Way in a southerly direction for 6 metres.

LINBY WALK (HUCKNALL) (both sides)

• from its junction with Carlingford Road in a northerly direction for 10 metres.

ST MARY'S WAY (HUCKNALL) (the north side)

from its junction with Linby Walk in a westerly direction for 8 metres

Vehicles will be prohibited from stopping on the 'School Keep Clear' markings on Monday to Friday between 8am and 4.30pm along the following: -

<u>CARLINGFORD ROAD (HUCKNALL)</u> (the south side)

from its junction with St Mary's Way in a southerly and then easterly direction for 26 metres.

ST MARY'S WAY (HUCKNALL) (the south side)

from its junction with Carlingford Road in a westerly direction for a distance of 6 metres.
