

The Nottinghamshire County Council (Burton Road, Cavendish Road, Garden City, Gedling Road, Manor Green Walk and Redland Grove, Carlton)(Prohibition of Waiting) Traffic Regulation Order 2017 (7189)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Carlton in the Borough of Gedling:-

1. **to prohibit waiting at any time at the following locations in Carlton,**
 - (i) **BURTON ROAD** (the south-east side)
from a point 10 metres south-west of its junction with Manor Green Walk in a north-easterly direction to a point 10 metres north-east of the same junction.
 - (ii) **CAVENDISH ROAD** (the south-west side)
from a point 5 metres north-west of its junction with Garden City in a south-easterly direction to a point 5 metres south-east of the same junction.
 - (iii) **GARDEN CITY** (both sides)
from its junction with Cavendish Road in a south-westerly direction for a distance of 5 metres.
 - (iv) **GEDLING ROAD** (the western side)
from a point 10 metres north of its junction with Redland Grove in a southerly direction to a point 6 metres south of the same junction.
 - (v) **MANOR GREEN WALK** (both sides)
from its junction with Burton Road to its junction with Manor Green
 - (vi) **REDLAND GROVE** (both sides)
from its junction with Gedling Road in a westerly direction for a distance of 10 metres.
2. **to prohibit waiting on Monday to Saturday - 8am to 6pm at the following location in Carlton**
 - (i) **BURTON ROAD** (south-east side)
from a point 8 metres south-west of a point opposite the centre line of Cavendish Drive in a north-easterly direction to a point 10 metres south-west of its junction with Manor Green Walk.
 - (ii) from a point 10 metres north-east of its junction with Manor Green Walk in a north-easterly direction to a point 48 metres north-east of the centre line of the same junction.
3. **other restrictions – Bus Stop Clearways – No stopping, except buses, at all times**
 - (i) **GEDLING ROAD** (eastern side) – outside No.s 8 – 14
 - (ii) **GEDLING ROAD** (western side) – outside No.s 3 - 7

The proposed parking restrictions are intended to keep the road clear of parked vehicles. The removal of parked vehicles will keep the junctions clear to allow pedestrians an unobstructed route across the road and will also give vehicles a clearer view when turning in or out. The restrictions on Manor Green Walk will give better access for residents.
