**CARLTON HILL, CARLTON
BUS STOP CLEARWAYS – NO STOPPING, EXCEPT BUSES, AT ALL TIMES.**

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce new bus stop clearways on Carlton Hill. In some locations the new no stopping at any time restriction will replace the existing no stopping between 7am and 7pm restriction. The bus stop locations are listed below:-

- Bus Stop GE0273 – O/S No.s 420 to 428 – currently clearway lines with no sign
- Bus Stop GE0274 – O/S No.s 361 to 365 – currently clearway lines with no sign
- Bus Stop GE0275 – O/S No.s 356 to 364 – currently in force from 7am to 7pm
- Bus Stop GE0290 – O/S No.s 303 to 305 – currently in force from 7am to 7pm
- Bus Stop GE0277 – O/S No.s 296 to 306 – currently in force from 7am to 7pm
- Bus Stop GE0265 – O/S No.s 273 to 277 – New clearway lines and sign
- Bus Stop GE0246 – O/S No.s 252 to 256 – New clearway lines and sign
- Bus Stop GE0247 – O/S No.s 222 to 224 – New clearway lines and sign
- Bus Stop GE0248 – O/S No.s 197 to 205 – New clearway lines and sign
- Bus Stop GE0249 – O/S No.s 176 to 180 – New clearway lines and sign
- Bus Stop GE0264 – O/S No.s 157 to 165 – New clearway lines and sign
- Bus Stop GE0110 – O/S No.87 and Centre House – New clearway lines and sign
- Bus Stop GE0111 – between Chesterfield St & Gladstone St – New clearway lines and sign
- Bus Stop GE0112 – O/S No. 37 – New clearway lines and sign
- Bus Stop GE0113 – Side of Tesco – New clearway lines and sign in existing lay-by
- Bus Stop GE0114 – near junction with Church Street – New clearway lines and sign

The whole length of Carlton Hill currently has a peak time waiting and loading restriction (between 4 – 6pm on the north side of the road and 7.30 – 9.30am on the south side of the road). There are no waiting at any time (double yellow lines) at the junctions off Carlton Hill.

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from indiscriminate parking. At the locations listed above, bus stop clearways are to be installed that prohibit other vehicles from parking or waiting in the bus stop at all times and these will be clearly identified with new road markings and signage.

The main benefits of bus stop clearways are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

Before proceeding further with the bus stop clearways, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me by **10th December 2018**.
