

**The Nottinghamshire County Council (Chandos Street and Louise Avenue, Netherfield,
Ambleside Way, Emerys Road, Shaw Gardens and William Close, Gedling)
(Prohibition and Restriction of Waiting) Traffic Regulation Order 2022 (7257)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Gedling and Netherfield in the Borough of Gedling:-

1. Proposed No waiting at any time restrictions (double yellow lines) at the following locations:-

- (i) AMBLESIDE WAY (GEDLING)(both sides)
from its junction with Emerys Road in a south-easterly direction for a distance of 10 metres.
- (ii) CHANDOS STREET (NETHERFIELD)(the north-west side)
from a point 10 metres south-west of its junction with Louise Avenue in a north-easterly direction to a point 10 metres north-east of the same junction.
- (iii) EMERYS ROAD (GEDLING)(the north-west side)
from a point 10 metres south-west of its junction with Shaw Gardens in a north-easterly direction to a point 10 metres north-east of the same junction.
- (iv) EMERYS ROAD (GEDLING) (the south-east side)
from a point 10 metres south-west of its junction with Ambleside Way in a north-easterly direction to a point 10 metres north-east of the same junction.
- (v) from a point 10 metres south-west of its junction with William Close in a north-easterly direction to a point 10 metres north-east of the same junction.
- (vi) from a point 10 metres south-west of its junction with the cul-de-sac serving No.s 57 to 75 Emerys Road in a north-easterly direction to a point 10 metres north-east of the same junction.
- (vii) from a point 10 metres south-west of its junction with the cul-de-sac serving No.s 37 to 55 Emerys Road in a north-easterly direction to a point 10 metres north-east of the same junction.
- (viii) from a point 10 metres south-west of its junction with the cul-de-sac serving No.s 17 to 35 Emerys Road in a north-easterly direction to a point 10 metres north-east of the same junction.
- (ix) from a point 10 metres south-west of its junction with the cul-de-sac serving No.s 7 to 15a Emerys Road in a north-easterly direction to a point 10 metres north-east of the same junction.
- (x) LOUISE AVENUE (NETHERFIELD)(both sides)
from its junction with Chandos Street in a north-westerly direction for a distance of 10 metres.
- (xi) SHAW GARDENS (GEDLING)(both sides)
from its junction with Emerys Road in a north-westerly direction for a distance of 10 metres.
- (xii) WILLIAM CLOSE (GEDLING)(both sides)
from its junction with Emerys Road in a south-easterly direction for a distance of 10 metres.

The double yellow lines are being proposed to remove parked vehicles from various junctions on Chandos Street and Emerys Road to give better visibility for vehicles turning in or out and give an unobstructed route for pedestrians who are crossing the road.
