**CHEWTON STREET, EASTWOOD – PROPOSED BUS STOP CLEARWAY - NO STOPPING  
EXCEPT BUSES – STAGE TWO CONSULTATION**

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, proposes to create a new enforceable bus stop clearway and relocate the existing bus stop pole at the following location and as shown on the attached site notice:-

No stopping except buses - 19 metre clearway  
• Chewton Street, Eastwood (BR0017)

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the location listed above, a new bus stop pole and bus stop clearway is to be installed to help serve the new housing development. This will prohibit other vehicles from parking or waiting in the bus stop at any time and will be clearly identified with new road markings and signage. The main benefits of the bus stop clearway are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

Further to the Stage One Consultation letter of the 3<sup>rd</sup> February 2025, the next stage of the consultation is to publicly advertise the scheme. Notices will be fixed on site and a plan showing the proposals is attached (Drawing Number H/JLB/4934/01) along with a copy of the site notice.

Any objections to the proposals, specifying the grounds on which they are made, should be sent in writing before the **4<sup>th</sup> April 2025** using the e-mail or postal address at the bottom of the letter.
