

The Nottinghamshire County Council (Church Avenue, Sutton-in-Ashfield) (Prohibition of Waiting and No Stopping on Entrance Clearways) Traffic Regulation Order 2018 (4212)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton-in-Ashfield in the District of Ashfield:-

1. Vehicles will be prohibited from waiting at any time along the following: -

CHURCH AVENUE, SUTTON-IN-ASHFIELD (north-east to south-west section) (the north-west side)

- from its junction with the south-easterly to north-westerly section of Church Avenue in a southwesterly direction for 5 metres
- from a point 42 metres south-west of its junction with the south-easterly to north-westerly section of Church Avenue in a south-westerly direction for 13 metres to its south-western extent

<u>CHURCH AVENUE</u>, <u>SUTTON-IN-ASHFIELD</u> (north-east to south-west section) (the south-east side)

• from its junction with the south-easterly to north-westerly length of Church Avenue in a south-westerly direction for 55 metres to its south-western extent

CHURCH AVENUE, SUTTON-IN-ASHFIELD (north-east to south-west section) (the south-west side)

• from its north-western extremity in a south-easterly direction for 18 metres to its south-eastern extremity

<u>CHURCH AVENUE, SUTTON-IN-ASHFIELD (south-east to north-west section)</u> (the north-east side)

• from its junction with Lammas Road in a north-westerly direction for 36 metres

CHURCH AVENUE, SUTTON-IN-ASHFIELD (south-east to north-west section) (the south-west side)

• from its junction with Lammas Road in a northerly direction for 52 metres

2. Vehicles will be prohibited from stopping on school entrance markings on Monday to Friday between 8am and 4.30pm along the following:-

CHURCH AVENUE (SUTTON-IN-ASHFIELD) (the north-east side)

 from a point 36 metres north of its junction with Lammas Road in a northerly direction for a distance of 26 metres
