INSTALLATION OF RAISED ZEBRA CROSSING (COMPTON ACRES, WEST BRIDGFORD)

PUBLIC CONSULTATION

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council is proposing to install a raised zebra crossing across Compton Acres, West Bridgford.

The proposed raised zebra crossing will be located on Compton Acres approximately 78 metres north of its junction with Belton Drive. It is being installed to assist pedestrians crossing Compton Acres including pedestrians traveling to the nearby nursery and shopping facilities.

The crossing will have a controlled area, indicated by zig-zag markings, along the carriageway where parking and loading will be prohibited. The effects of the road hump will be a single 75mm high, 9.5m long (including approach ramps), flat-topped road hump (plateau).

The location of the proposed crossing is shown on the attached plan: 2250873-GEN-002 Consultation Plan.

As required under Section 23 of the Road Traffic Regulation Act 1984 (zebra crossing) and Section 90A - 90I of the Highways Act 1980 (traffic calming hump), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the zebra crossing and road hump on Compton Acres, West Bridgford.

All comments/objections should be sent to either the e-mail address or postal address below (stating grounds and quoting ref. Compton Acres – Raised Crossing). Any observations on these proposals should reach me in writing, either by letter or email, by **12th February 2023**. If your comments are in the form of an objection to the proposals please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
