

### The Nottinghamshire County Council (Various Roads off Church Road and Main Street in Burton Joyce (Prohibition of Waiting) Traffic Regulation Order 2019 (7207)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads, Burton Joyce in the Borough of Gedling: -

Vehicles will be prohibited from waiting at any time along the following lengths of roads: -

#### CARNARVON DRIVE (BURTON JOYCE) (north east side)

(i) from its junction with Main Street in a south easterly direction for 13 metres.

CARNARVON DRIVE (BURTON JOYCE) (south west side)

(ii) from its junction with Main Street in a south easterly direction for 12 metres.

CHESTERFIELD DRIVE (BURTON JOYCE) (Southern Arm) (north east side)

## (i) from its junction with Main Street in a south easterly direction for 11 metres.

- CHESTERFIELD DRIVE (BURTON JOYCE) (Southern Arm) (south west side)
- (i) from its junction with Main Street in a south easterly direction for 10 metres.
- CHESTNUT GROVE (BURTON JOYCE) (the north east side)
  - (i) from its junction with Main Street in a south easterly direction for 10 metres.
  - (ii) from a point 10 metres north east of its junction with Church Road in a south easterly direction to a point 26 metres south east of that junction.

#### CHESTNUT GROVE (BURTON JOYCE) (south west side)

- (i) from its junction with Main Street in a south easterly direction for 10 metres
- (ii) from a point 10 metres north west of its junction with Church Road in a south easterly direction to a point 14 metres south east of that junction.
- (iii) from a point 73 metres south east of its junction with Church Road in a south westerly direction for 14 metres.
- (iv) from its southern extremity in a north and then a south westerly direction for 23 metres.

#### CHURCH ROAD (BURTON JOYCE) (A612) (north west side)

- (i) from a point 10 metres south west of its junction with Chestnut Grove in a north easterly direction to a point 10 metres north east of that junction.
- (ii) from a point 26 metres south west of its junction with Meadow Lane in a north easterly direction to a point 33 metres north east of that junction.
- (iii) from a point 22 metres south west of its junction with Shaftesbury Avenue in a north easterly direction to a point 12 metres north east of that junction

#### CHURCH ROAD (BURTON JOYCE) (A612) (south east side)

- (i) from a point 10 metres south west of its junction with St Helen's Crescent in a north easterly direction to a point 13 metres north east of that junction.
- (ii) from its junction with Chestnut Grove in a south westerly direction for 10 metres.
- (iii) from a point 35 metres south west of its junction with Trent Lane in a north easterly direction to a point 30 metres north east of that junction.
- (iv) from a point 22 metres south west of its junction with Shaftesbury Avenue in a north easterly direction to a point 13 metres north east of that junction.

#### CHURCH ROAD (SERVICE ROAD) (BURTON JOYCE) (north west side)

(i) from its junction with Chestnut Grove in a north easterly direction for 12 metres.

#### CHURCH ROAD (SERVICE ROAD) (BURTON JOYCE) (south east side)

- (i) from its junction with Chestnut Grove in a north easterly direction for 8 metres.
- (ii) from a point 7 metres south west of its junction with Winifred Crescent in a north
  - easterly direction to a point 7 metres north east of that junction.

#### HILLSIDE DRIVE (both sides)

- (i) from its junction with Main Street in a north westerly direction for 10 metres
- LAMBLEY LANE (BURTON JOYCE) (north east side)

(i) from a point 10 metres north west of its junction with Main Street in a south easterly direction to a point 14 metres south east of that junction.

#### LAMBLEY LANE (BURTON JOYCE) (south west side)

(i) from a point 10 metres north west of its junction with Main Street in a south easterly direction to a point 13 metres south east of that junction.

#### MAIN STREET (BURTON JOYCE) (north western side)

- (i) from a point 10 metres south west of its junction with Lambley Lane in a north easterly direction to a point 10 metres north east of that junction.
- (ii) from a point 12 metres south west of its junction with Padleys Lane in a north easterly direction to a point 11 metres north east of that junction
- (iii) from its junction with Wheatsheaf Court in a south westerly direction for 8 metres.
- (iv) from a point 12 metres south west of its junction with Willow Wong in a north easterly direction to a point 10 metres north east of that junction.
- (v) from a point 10 metres south west of its junction with Hillside Drive in a north easterly direction to a point 10 metres north east of that junction

#### MAIN STREET (BURTON JOYCE) (south eastern side)

- (i) from a point 13 metres south west of its junction with Lambley Lane in a north easterly direction to a point 10 metres north east of that junction.
- (ii) from a point 5 metres south west of its junction with Chestnut Grove in a north easterly direction to a point 11 metres north east of that junction.
- (iii) from a point 15 metres south west of its junction with Meadow Lane in a north easterly direction to a point 10 metres north east of that junction.
- (iv) from a point 12 metres south west of its junction with Carnarvon Drive in a north easterly direction to a point 10 metres north east of that junction.
- (v) from a point 10 metres south west of its junction with Chesterfield Drive (southern arm) in a north easterly direction to a point 10 metres north east of that junction.

#### MEADOW LANE (BURTON JOYCE) (south west side)

- (i) from its junction with Main Street in a south easterly direction for 10 metres.
- (ii) from its junction with Church Road(A612) in a north westerly direction for 15 metres

#### PADLEYS LANE (BURTON JOYCE) (both sides)

(i) from its junction with Main Street in a north westerly direction for 11 metres.

#### SHAFTESBURY AVENUE (BURTON JOYCE) (north east side))

(i) from a point 10 metres north west of its junction with Church Road(A612) in a south easterly direction to a point 10 metres south east of that junction.

#### St HELEN'S CRESCENT (BURTON JOYCE) (south west side)

(i) from its junction with Church Road in a south easterly direction for 10 metres.

#### TRENT LANE (BURTON JOYCE) (the north east side)

(i) from its junction with Church Road (A612) in a south easterly direction for 10 metres.

#### TRENT LANE (BURTON JOYCE) (the south west side)

(i) from its junction with Church Road (A612) in a south easterly direction for 20 metres.

#### WINIFRED CRESCENT (BURTON JOYCE) (both sides)

(i) from its junction with Church Road (Service Road) in a south easterly direction for 10 metres. **WILLOW WONG (BURTON JOYCE)** (south east side))

(i) from its junction with Main Street in a north westerly direction for 11 metres.

#### WILLOW WONG (BURTON JOYCE) (south west side)

- (i) from its junction with Main Street in a north westerly direction for 10 metres.
