

The Nottinghamshire County Council (Dalestorth Street, Hill Crescent, Redcliffe Street and Skegby Road, Sutton-in-Ashfield) (Prohibition of Waiting) Traffic Regulation Order 2018 (4217)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton-in-Ashfield in the District of Ashfield:-

Vehicles will be prohibited from waiting at any time along the following: -

DALESTORTH STREET, SUTTON-IN-ASHFIELD (the north-west side)

- from its junction with Redcliffe Street in a north-easterly direction for 21 metres

DALESTORTH STREET, SUTTON-IN-ASHFIELD (the south-east side)

- from a point 7 metres north-east of its junction with Skegby Road in a south-westerly direction to a point 20 metres south-west of that junction

HILL CRESCENT, SUTTON-IN-ASHFIELD (the north-west side)

- from its junction with Skegby Road in a north-easterly direction for 12 metres

HILL CRESCENT, SUTTON-IN-ASHFIELD (the south-east side)

- from its junction with Skegby Road in a north-easterly direction for 14 metres

REDCLIFFE STREET, SUTTON-IN-ASHFIELD (both sides)

- from its junction with Dalestorth Street in a westerly direction for 18 metres

SKEGBY ROAD, SUTTON-IN ASHFIELD (the north-east side)

- from its junction with Dalestorth Street in a south-easterly direction for 25 metres
- from its junction with Harwood Close in a north-westerly direction for 17 metres
- from a point 10 metres north-west of its junction with Hill Crescent in a south-easterly direction to a point 12 metres south-east of that junction

SKEGBY ROAD, SUTTON-IN-ASHFIELD (the south-west side)

- from its junction with Dalestorth Street in a south-easterly direction for 19 metres
- from a point 8 metres north-west of its junction with Thoresby Street in a south-easterly direction to a point 6 metres south-east of that junction
