

**THE NOTTINGHAMSHIRE COUNTY COUNCIL**  
**(EDWINSTOWE AND KINGS CLIPSTONE)(7.5 AND 18 TONNES WEIGHT**  
**RESTRICTION)TRAFFIC REGULATION ORDER 2018 (3282)**

**NOTICE IS HEREBY GIVEN** that the NOTTINGHAMSHIRE COUNTY COUNCIL proposes to make an Order under Sections 1(1) and (2), 2(4) and 3(2) of the Road Traffic Regulation Act 1984, as amended.

1. The effect of the Order will be, in respect of roads at Edwinstowe and Kings Clipstone in the District of Newark and Sherwood, no heavy commercial vehicle with an operating weight exceeding **7.5 Tonnes** shall proceed in any of the following roads or lengths of road:-

Abbey Road, Beardsley Road, B6034 High Street/B6034 Rufford Road, Boy Lane, Brocklehurst Drive, Carver Close, Dovedale Close, East Lane, Fifth Avenue, First Avenue, Fourth Avenue, Gaitskell Crescent, Greenfield Close, Greenwood Avenue, Hawthorne Way, Henton Road, King Edwins Close, Lansbury Road, Lynds Close, Meadow Close, Merryweather Close, Mill Lane, Oakwood Drive, Occupation Lane, Old Station Yard, Pinewood Avenue, Robin Hood Avenue, Sandy Lane, Second Avenue, Sixth Avenue, Third Avenue, West Lane, Woodhead Close.

2. The effect of the Order will be, in respect of roads at Kings Clipstone in the District of Newark and Sherwood, no heavy commercial vehicle with an operating weight exceeding **18 Tonnes** shall proceed on the following road:-

Gorsethorpe Lane

The Order is intended to preserve or improve the amenities of the area by prohibiting or restricting the use on roads in the area by heavy goods vehicles, especially through Edwinstowe village centre. The proposed 7.5 tonne weight limit is to replace the existing 18 tonne weight limit (except on Gorsethorpe Lane)
