

**The Nottinghamshire County Council (Junctions off Big Barn Lane, Mansfield)
(Prohibition of Waiting) Traffic Regulation Order 2021 (2230)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Mansfield in the District of Mansfield:-

Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

BEAUMONT AVENUE, MANSFIELD (both sides)

- From its junction with Big Barn Lane in a north-westerly direction for 10 metres.

BIG BARN LANE, MANSFIELD (the north-west side)

- From a point 10 metres north-east of its junction with Beaumont Avenue in a south-westerly direction to a point 10 metres south-west of that junction.
- From a point 12 metres north-east of its junction with Earlswood Drive in a south-westerly direction to a point 13 metres south-west of that junction.

BIG BARN LANE, MANSFIELD (the south-east side)

- From a point 10 metres north-east of its junction with Lingfield Close in a south-westerly direction to a point 12 metres south-west of that junction.
- From a point 21 metres north-east of its junction with Greenacre in a south-westerly direction to a point 10 metres south-west of that junction.
- From a point 10 metres north-east of its junction with Firbeck Avenue in a south-westerly direction to a point 10 metres south-west of that junction.

EARLSWOOD DRIVE, MANSFIELD (the northern side)

- From its junction with Big Barn Lane in an easterly direction for 40 metres.

EARLSWOOD DRIVE, MANSFIELD (the southern side)

- From its junction with Big Barn Lane in an easterly direction for 33 metres.

FIRBECK AVENUE, MANSFIELD (the north-east side)

- From its junction with Big Barn Lane in a south-easterly direction for 10 metres.

FIRBECK AVENUE, MANSFIELD (the south-west side)

- From its junction with Big Barn Lane in a south-easterly direction for 13 metres.

GREENACRE, MANSFIELD (both sides)

- From its junction with Big Barn Lane in a south-easterly direction for 12 metres.

LINGFIELD CLOSE, MANSFIELD (both sides)

- From its junction with Big Barn Lane in a south-easterly direction for 10 metres.
