

The Nottinghamshire County Council (Normanton Road, Mill Park, Riverside and Station Road, Southwell) (Prohibition of Waiting) Traffic Regulation Order 2021 (3309)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Southwell in the District of Newark and Sherwood: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

MILL PARK, SOUTHWELL (the north-east side)

• from its junction with Normanton Road in a north-westerly direction for 20 metres.

MILL PARK, SOUTHWELL (the south-west side)

• from its junction with Normanton Road in a north-westerly direction for 17 metres.

NORMANTON ROAD, SOUTHWELL (the north-west side)

• from its junction with Mill Park in a north-easterly direction for 11 metres.

NORMANTON ROAD, SOUTHWELL (the south-east side)

 from a point opposite the south-western kerb line of Mill Park in a north-easterly direction for 23 metres.

RIVERSIDE, SOUTHWELL (north-east side)

• from its junction with Station Road in a south-easterly direction for 12 metres.

RIVERSIDE, **SOUTHWELL** (south-west side)

from its junction with Station Road in a south-easterly direction for 13 metres.

STATION ROAD, SOUTHWELL (the north-west side)

from its junction with Mill Park in a south-westerly direction for 19 metres.

STATION ROAD, SOUTHWELL (the south-east side)

• from a point 23 metres south-west of its junction with Riverside in a north -easterly direction to a point 16 metres north-east of that junction.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall libraries are closed or if reopened will have restrictions in place.
