

The Nottinghamshire County Council (Bullpit Road and Wolfit Avenue, Balderton) (Prohibition of Waiting) Traffic Regulation Order 2020 (3310)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads in Balderton in the District of Newark and Sherwood.: -

1. Vehicles will be prohibited from waiting at any time along the following lengths of road: -

BULLPIT ROAD, BALDERTON (the east side)

o from its junction with Wolfit Avenue in a north-easterly direction for 24 metres.

BULLPIT ROAD, BALDERTON (the north side)

o from a point 3 metres east of the building line of 19 Bullpit Road in an easterly then north easterly direction for 58 metres.

BULLPIT ROAD, BALDERTON (the south side)

o from its junction with Wolfit Avenue in a westerly direction for 28 metres

WOLFIT AVENUE, BALDERTON (the north side)

from its junction with Wolfit Avenue in a south-westerly direction for 28 metres.

- 2. Vehicles will be prohibited from stopping on school entrance markings on Monday to
 - o Friday between 8am and 4.30pm along the following: -

WOLFIT AVENUE, BALDERTON (south side)

- o from a point 26 metres south-east of its junction with Bullpit Road in a south-easterly direction for 26 metres.
- 3. Other restrictions **Bus Stop Clearways** No stopping, except buses, at any time.

BULLPIT ROAD, BALDERTON

o Bus Stop NS0275 – introduce 19-metre-long bus stop clearway.

BULLPIT ROAD, BALDERTON

Bus Stop NS0071 – introduce 37-metre-long bus stop clearway.

WOLFIT AVENUE, BALDERTON

Bus Stop NS0708 – relocate and introduce 19-metre-long bus stop clearway.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall libraries are closed or if reopened will have restrictions in place.
