

The Nottinghamshire County Council
(Cross Lane, Unnamed Road and William Hall Way, Newark)
(Prohibition of Waiting) Traffic Regulation Order 2020 (3307)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads, in the District of Newark and Sherwood: -

1. Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

CROSS LANE, NEWARK (north side)

- From its junction with B6326 in a south-westerly direction for 66 metres
- From a point 108 metres south-west of its junction with the B6326 in a south-westerly direction to a point 56 metres north-east of its south-western extremity.
- From its south-western extremity in a north-easterly direction for 32 metres

CROSS LANE, NEWARK (south side)

- From its junction with B6326 in a south-westerly direction for 238 metres
- From a point 95 metres north-east of its south-western extremity in a north-easterly direction for 28 metres.
- From its south-western extremity in a north-easterly direction for 77 metres.

UNAMED ROAD, NEWARK (north-east side)

- From its junction with William Hall Way in a north-westerly direction to its north-western extremity.

UNAMED ROAD, NEWARK (south-west side)

- From its junction with William Hall Way in a north-westerly direction for 27 metres.
- From a point 63 metres north-west of its junction with William Hall Way in a north-westerly direction to its north-western extremity.

WILLIAM HALL WAY, NEWARK (both sides)

- From its junction with B6326 in a south-westerly then southerly direction to a point 44 metres south of the outside perimeter of the roundabout with Cross Lane

2. Vehicles will be prohibited from **Waiting between 6pm-6am** along the following length of road:

CROSS LANE, NEWARK (north side)

- From a point 66 metres south-west of its junction with B6326 in a south-westerly direction for 42 metres

- From a point 32 metres north-east of its south-western extremity in a north-easterly direction for 24 metres.

CROSS LANE, NEWARK (south side)

- From a point 77 metres north-east of its south-western extremity in a north-easterly direction for 18 metres.
- From a point 123 metres north-east of its south-western extremity in a north-easterly direction for 36 metres.

UNAMED ROAD, NEWARK (south-west side)

- From a point 27 metres north-west of its junction with William Hall Way in a north-westerly direction for 36 metres.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall libraries are closed or if reopened will have restrictions in place.
