**(Ash Lea Close, Bingham Road, Candleby Lane, Church Lane, Main Road,  
Owthorpe Road, Plumtree Road and The Old Park, Cotgrave)  
(Prohibition of Waiting) Traffic Regulation Order 2021 (8302)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Cotgrave in the Borough of Rushcliffe:

1. Vehicles will be prohibited from **Waiting at Any Time** along the following lengths of road: -

**Ash Lea Close, Cotgrave** (north-west side)

from its junction with Owthorpe Road in a north-easterly direction for 13 metres

**Ash Lea Close, Cotgrave** (south-east side)

from its junction with Owthorpe Road in a north-easterly direction for 30 metres

**Bingham Road, Cotgrave** (south-west side)

from its junction with Plumtree Road in a south-easterly direction for 23 metres

**Church Lane, Cotgrave** (north side)

(i) from its junction with Plumtree Road in a westerly direction for 10 metres.

(ii) from a point 42 metres west of its junction with Plumtree Road in a westerly direction for 36 metres

**Church Lane, Cotgrave** (south side)

from its junction with Plumtree Road in a westerly direction for 70 metres.

**Main Road, Cotgrave** (south-west side)

from its junction with Plumtree Road in a north-westerly direction for 20 metres

**Owthorpe Road, Cotgrave** (north-east side)

from a point 22 metres north-west of its junction with Ash Lea Close in a south-easterly direction to a point 12 metres south east of that junction.

**Plumtree Road, Cotgrave** (north-west side)

from its junction with Main Road in a south-westerly direction for 32 metres.

**Plumtree Road, Cotgrave** (south-east side)

from its junction with Bingham Road in a south-westerly direction for 17 metres.

**The Old Park, Cotgrave** (both sides)

from its junction with Bingham Road in a north-westerly direction for direction for 13 metres.

2. Vehicles will be prohibited from **Waiting between Mon-Sat, 8am- 6pm** along the following length of road:

**Candleby Lane, Cotgrave** (the south-west side)

from its junction with Candleby Lane in a south-easterly direction for 65 metres.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall libraries are closed or if reopened will have restrictions in place.
