

THE NOTTINGHAMSHIRE COUNTY COUNCIL (UNNAMED ROAD, OUTSIDE SUTHERS SCHOOL, FERNWOOD) (PROHIBITION OF WAITING AND NO STOPPING ON ENTRANCE CLEARWAYS) TRAFFIC REGULATION ORDER 2020 (3317)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Fernwood in the District of Newark and Sherwood

1. Vehicles will be prohibited from waiting at any time along the following: -

<u>UNNAMED ROAD, FERNWOOD</u> (east side)

• from a point 10 metres south of its junction with Cross Lane in a south-easterly direction for 190 metres to its southern extremity.

UNNAMED ROAD, FERNWOOD (west side)

- from a point 10 metres south of its junction with Cross Lane in a south-easterly direction for 54 metres
- from a point 101 metres south of its junction with Cross Lane in a south-easterly direction for 20 metres
- from a point 175 metres south of its junction with Cross Lane in a south-easterly direction to its southern extremity.
- 2. Vehicles will be prohibited from waiting between 6pm and 6am along the following: -

<u>UNNAMED ROAD, FERNWOOD</u> (west side)

- from a point 121 metres south of its junction with Cross Lane in a south-easterly direction for 54 metres
- 3. Vehicles will be prohibited from stopping on school entrance markings on Monday to Friday between 8am and 4.30pm along the following: -

UNNAMED ROAD, FERNWOOD (west side)

• from a point 64 metres south east of its junction with Cross Lane in a south easterly direction for 37 metres.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall libraries are closed or if reopened will have restrictions in place.
