**(30 M.P.H. RESTRICTED ROAD AND 40 M.P.H SPEED LIMITS) ORDER 2025**  
**(3415)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an order under the Road Traffic Regulation Act 1984, the effects of which will be, in respects of roads at Newark in the District of Newark and Sherwood in the County of Nottinghamshire.

1. The length of road specified in Schedule 1 of this Order shall be a Restricted Road (30mph) for the purpose of Section 81 of the Act
2. No person shall drive any vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 of this Order.

**SCHEDULE 1**

**HAWTON ROAD, NEWARK**

- From a point 138 metres south-west of its junction with Riverside Road in a south-westerly direction to its junction with the Hawton Road – Middlebeck Way roundabout.
- From its junction with the Hawton Road – Middlebeck Way roundabout in a south-westerly direction for 23 metres.

**SCHEDULE 2**

**MIDDLEBECK WAY, NEWARK**

- From its junction with the A46 - Middlebeck Way roundabout, in a south-easterly direction for 821 metres, including the entire circulatory of the Hawton Road – Middlebeck Way roundabout and the entire circulatory of the Middlebeck Way roundabout.
