

<u>The Nottinghamshire County Council (Kenbrook Road,</u> <u>Paulina Avenue, Roman Crescent and Ryknield Road, Hucknall)</u> (Prohibition of Waiting) Traffic Regulation Order 2020 (4266)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Hucknall in the District of Ashfield:-

Proposed No waiting at any time restrictions (double yellow lines) at the following location:-

- 1. KENBROOK ROAD (the north side)
- (i) from a point 38 metres east of its junction with Ryknield Road in an easterly direction for a distance of 24 metres.
- (ii) from a point 20 metres west of its junction with Roman Crescent in an easterly direction to a point 18 metres east of the same junction.
- 2. KENBROOK ROAD (the north-west side)
- (i) from a point 36 metres south-west of its junction with Ryknield Road in a north-easterly and an easterly direction to a point 24 metres east of the same junction.
- 3. KENBROOK ROAD (the south-east side)
- (i) from a point 33 metres south-west from its junction with Paulina Avenue in a north-easterly and then an easterly direction to a point 65 metres east of the same junction.
- 4. PAULINA AVENUE (both sides)
- (i) from its junction with Kenbrook Road in a south-easterly direction for 11 metres.
- 5. ROMAN CRESCENT (both sides)
- (i) from its junction with Kenbrook Road in a northerly direction for a distance of 10 metres.
- 6. <u>RYKNIELD ROAD (both sides)</u>
- (i) from its junction with Kenbrook Road in a north-westerly direction for 12 metres.

Proposed No waiting on all days - 7am and 7pm restrictions (single yellow lines) at the following location:-

- 7. KENBROOK ROAD (the south side)
- (i) from a point 59 metres west of a point opposite the western kerb line of Roman Crescent in an easterly direction for a distance of 142 metres.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall and libraries are closed or if reopened will have restrictions in place.

The proposed restrictions are intended to remove parked vehicles to allow the passage of larger vehicles, especially the new bus service which is to be introduced on Kenbrook Road. The restrictions will also ensure that pedestrians will have an unobstructed route across the road at the junctions. The single yellow line will keep this side of the road clear of obstructions during the day when the bus service is in operation. On-street parking would be available during the evening and overnight.
