

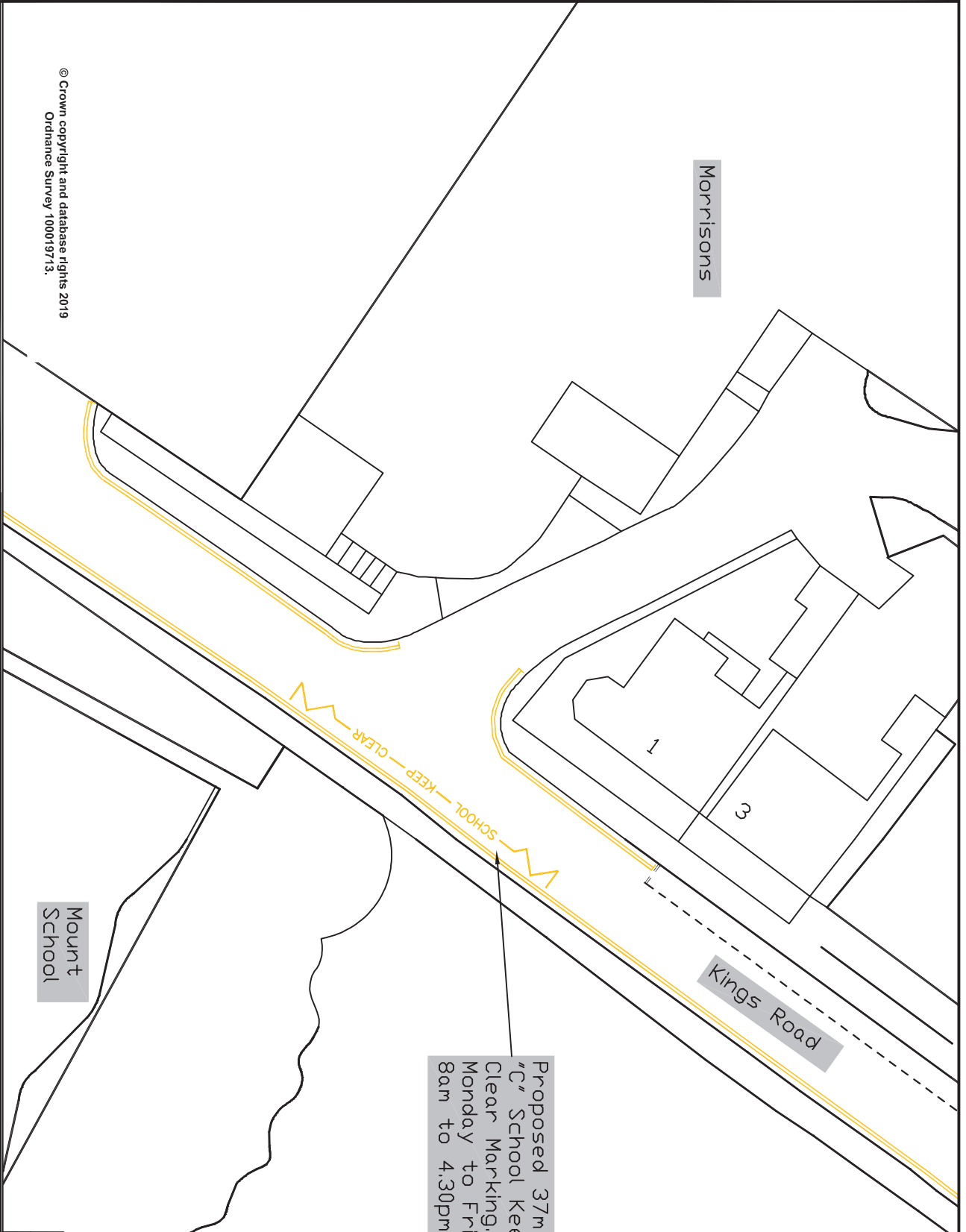

CLEARWAY) TRAFFIC REGULATION ORDER 2019 (3291)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and the Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No.1086), as amended, the effects of which will be to roads in Newark On Trent in the District of Newark & Sherwood:-

1. To prohibit stopping on school entrance markings **Monday to Friday 8am to 4.30pm** at the following location:-

Kings Road, Newark on Trent – From a point 17 metres north east of the centre line of Morrisons entrance in a south westerly direction for 37m
