

THE NOTTINGHAMSHIRE COUNTY COUNCIL (MAIN ROAD AND NOTTINGHAM ROAD, RADCLIFFE ON TRENT) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8393)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Radcliffe on Trent in the District of Rushcliffe: -

1. **Proposed Prohibition of Waiting At Any Time** along the following lengths of road: -

MAIN ROAD, RADCLIFFE ON TRENT (The North side)

- From a point 11 metres south-west of its junction with The Green in a south-westerly direction for 42 metres.
- From a point 13 metres east of its junction with The Green in an easterly direction for 30 metres.
- From a point opposite a point 8 metres northeast of Mount Pleasant (measured from the centre line), in a north easterly direction for 30 metres.

MAIN ROAD, RADCLIFFE ON TRENT (The South-East side)

- From its junction with Water Lane in a northerly direction for 22 metres

MAIN ROAD, RADCLIFFE ON TRENT (The West side)

- From its junction with Nottingham Road in a northerly direction of 25 metres.

NOTTINGHAM ROAD, RADCLIFFE ON TRENT (Both sides)

- From its junction with Main Road in a westerly direction for 33 metres

WATER LANE, RADCLIFFE ON TRENT (The North Side)

- From its junction with Main Road, in an easterly direction for 20 metres.

2. **PROPOSED BUS STOP CLEARWAY - No Stopping at any time except for buses** along the following lengths of road:

MAIN ROAD, RADCLIFFE ON TRENT (The South-east side)

- From a point 30 metres east of its junction with Cutlers Court in an easterly direction for 19 metres.

NOTTINGHAM ROAD, RADCLIFFE ON TRENT (The South-east side)

- From a point 74 metres north-east of its junction with St Lawrence Boulevard in a north-easterly direction for 19 metres.
