MILE END ROAD AT ITS JUNCTIONS WITH COLWICK MANOR FARM, CROSSLANDS MEADOW AND RAMBLERS CLOSE. MILE END ROAD BETWEEN RAMBLERS CLOSE AND A612 – PROPOSED PROHIBITION OF WAITING AT ANY TIME (DOUBLE YELLOW LINES) – PUBLIC CONSULTATION (REVISED)

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce double yellow lines (no waiting at any time) to the junctions of Mile End Road with Colwick Manor Farm, Crosslands Meadow and Ramblers Close. The proposed double yellow lines at the junctions were originally consulted on in August/September 2020. As a result of comments received during the initial consultation it has been decided to extend the proposed double yellow lines. On the north-east side of Mile End Road the additional lines would extend from the junction with Ramblers Close to outside 25 Mile End Road. On the opposite side the lines would extend from opposite Ramblers Close to the junction with the A612. Additional lines are also proposed on Mile End Road opposite the junction with Crosslands Meadow.

The proposed double yellow lines are being introduced to remove parked vehicles from the 3 junctions off Mile End Road, from around the bend and pedestrian refuge on Mile End Road and from opposite Crosslands Meadow. The proposed restrictions will give better visibility for vehicles turning into or out of the junctions and will also give an unobstructed route for pedestrians to cross the road. The additional lines will help ensure that visibility around the bend is not obscured by parked vehicles and will make it easier for vehicles to turn into or out of Crosslands Meadow.

The positions and extents of the proposed double yellow lines are shown on the enclosed drawing and notice.

Before proceeding further, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me in writing, either by letter (address at bottom of letter) or email, by **14th December 2020**.
