New Sharphill Primary School - Proposed Parking Restrictions (TRO 8289)

Rose Way and Wheatcroft Drive, Edwalton – NEW PUBLIC ADVERT (JUNE 2020)

The consultation for this scheme was originally advertised in March 2020. The consultation was stopped due to the restrictions imposed by the coronavirus measures which meant that the consultation documents could not be viewed at the local library or County Hall. The Government has since relaxed the requirement to have the documents on deposit. The documents can now be viewed on either the Nottinghamshire County Council website or they can be sent to you by post or e-mail on request.

As part of the development works at Sharphill Primary School on Rose Way, Edwalton, Via East Midlands, working on behalf of the County Council, is proposing to introduce a school safety zone. This will consist of a package of measures including warning signs, pedestrian guardrail, bollards, waiting and stopping restrictions. It is proposed to implement no waiting at any time (Double Yellow Lines) parking restrictions on Rose Way, Wheatcroft Drive and the new school vehicular entrance. These restrictions will help ensure that the junctions and bends in the vicinity of the new school are kept clear of parked vehicles. Outside the school pedestrian entrances it is proposed to introduce School Keep Clear markings. The restrictions will prohibit vehicles from stopping on Monday to Friday between 8am and 4.30pm. This will help to keep the road outside the school clear of vehicles during the school day making it safer for pupils attending the school. The restrictions will also promote the safe and efficient movement of people and vehicles on the Highway by ensuring that key junctions, crossing points and bends are kept free of parked vehicles at all times.

As part of this work the lines will be marked on site and new signs erected. The proposals are shown on the attached drawing H/JAB/3329/01. A copy of the site notice is also attached.

All responses received as part of the original consultation will be taken forward and will be reported through the County Council's procedures.

Any further observations on these proposals should reach me in writing, either by letter or email, by **20th July 2020**. If your comments are in the form of an objection to the proposals please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
