

**THE NOTTINGHAMSHIRE COUNTY COUNCIL**  
**(PRESTON ROAD, RAINWORTH) (PROHIBITION OF WAITING)**  
**TRAFFIC REGULATION ORDER 2026 (3426)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Rainworth the District of Newark and Sherwood: -

**1. PRESTON ROAD, (RAINWORTH)**

(the north side)

From a point 10 metres east of its junction with Station Road in a westerly direction to a point 15 metres west of that junction.

**2. PRESTON ROAD, (RAINWORTH)**

(the south side)

From a point 10 metres east of its junction with Preston Road (North-to-South Leg) in a westerly direction to a point 15 metres west of that junction.

**3. PRESTON ROAD, (RAINWORTH) (North-to-South Leg)**

(the east side)

From its junction with Preston Road in a southerly direction for 10 metres.

**4. PRESTON ROAD, (RAINWORTH) (North-to-South Leg)**

(the west side)

From its junction with Preston Road in a southerly direction for 10 metres.

**5. STATION ROAD, (RAINWORTH)**

(the east side)

From its junction with Preston Road in a northerly direction for 10 metres.

**6. STATION ROAD, (RAINWORTH)**

(the west side)

From its junction with Preston Road in a northerly direction for 10 metres.
