

**The Nottinghamshire County Council (Colwick Road, Orston Road West, Pavilion Road
Trentside North, West Bridgford)(Prohibition of Waiting, Parking Places and Controlled Parking
Zones) Traffic Regulation Order 2019 (8296) and
(Colwick Road, Pavilion Road and Trentside North, West Bridgford) (One Way Streets and
Prohibition of Driving) Traffic Regulation Order (8297)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in West Bridgford in the Borough of Rushcliffe:-

1. to prohibit waiting at any time on parts of the following roads.
Colwick Road – West Side –
 - (I) from its junction with Radcliffe Road in a northerly direction for a distance of 20 metres.
 - (ii) from a point 32 metres north of its junction with Radcliffe Road in a northerly direction for a distance of 5 metres.**Pavilion Road – south-east side**
 - (iii) from its junction with Trent Bridge in north-easterly direction for a distance of 28 metres.
 - (iv) from a point 36 metres north-east of its junction with Trent Bridge in north-easterly direction for 28 metres.**Pavilion Road – west side**
 - (v) from its junction with Radcliffe Road in a northerly direction for a distance of 18 metres.
 - (vi) from a point 33 metres north of its junction with Radcliffe Road in a northerly direction for 7 metres.
 - (vii) from a point 45 metres north of its junction with Radcliffe Road in a northerly direction for 7 metres.
 - (viii) from a point 59 metres north of its junction with Radcliffe Road in a northerly direction for 6 metres.
2. Introduce amended parking bays (Mon – Sat, 8am to 6pm, 1 hour waiting, no return within 1 hour) at the following locations.
Colwick Road – West Side
 - (i) from a point 20 metres north of its junction with Radcliffe Road in a northerly direction for 12 metres.
 - (ii) from a point 37 metres north of its junction with Radcliffe Road in a northerly direction for 5 metres.**Pavilion Road – south-east side**
 - (iii) from a point 64 metres north-east of its junction with Trent Bridge in a north-easterly direction for 28 metres.**Pavilion Road – west side**
 - (iv) from a point 18 metres north of its junction with Radcliffe Road in a northerly direction for 15 metres.
3. Introduce a Controlled Parking Zone (No waiting and No Loading) on Event Days (Football matches or other events at the Nottingham Forest Football Ground) to be in force on Mon – Fri, 6 -10pm and Bank Holidays, Sat & Sun, 10am – 10pm on the following roads
 - (i) **Colwick Road, Orston Road West, Pavilion Road and Trentside North.**
4. **One Way Streets (amendment to existing)**
 - (i) **Pavilion Road** - (south-west to north-east section) from its junction with Trent Bridge in a north-easterly direction for 16 metres.
5. **Prohibition of Driving on Event Days (Football matches or other events at the Nottingham Forest Football Ground) to be in force on Mon – Fri, 6 -10pm and Bank Holidays, Sat & Sun, 10am – 10pm at the following locations (road to be closed by either gates or bollards on Event Days) – except access permit holders accessing Pavilion Rd or Colwick Rd off Radcliffe Rd**
 - (i) On **Colwick Road** at its junction with **Radcliffe Road**
 - (ii) On **Pavilion Road** at its junction with **Trent Bridge (A60)**
 - (iii) On **Pavilion Road** at its junction with **Radcliffe Road**
 - (iv) On **Trentside North** at its junction with **Trent Bridge (A60)**

The above restrictions are being introduced as part of the measures to protect members of the public, attending events at the Nottingham Forest Football ground, from hostile vehicles. The restrictions will prohibit all waiting, loading and access during an event day. The next event day will be displayed on variable message signs located at the start of the Controlled Parking Zones. The number of parking bay spaces (on non-event days) on Pavilion Road will increase by approximately 3 spaces and will decrease by approximately 3 spaces on Colwick Road. On event days when the gates or bollards are open then access will be permitted for drivers who wish to gain access or egress to premises off the Highway, waiting and loading within the Controlled Parking Zone will still be enforced. In addition access off Radcliffe Rd will be allowed to all residents displaying a valid access permit at all times on an event day.
