

THE NOTTINGHAMSHIRE COUNTY COUNCIL
(CENTURY ROAD ,GRACE ROAD, ORDSALL ROAD, NEWLANDS, OLLERTON ROAD, WEST HILL ROAD, ORDSALL, RETFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2017 (1200)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Ordsall in the District of Bassetlaw :-

- (1) Vehicles will be prohibited from waiting at any time in the following length of road:-
- (a) Ordsall Road, (West to East section) the north-west side, from its junction with West Hill Road in a north-easterly direction for a distance of 30 metres.
 - (b) Ordsall Road, (West to East section) the south-east side, from its junction with West Hill Road in a north-easterly direction for a distance of 65 metres.
 - (c) Ordsall Road, (West to East section) both sides, from its junction with Ollerton Road in a westerly direction for a distance of 15 metres.
 - (d) Ordsall Road, (North-West to South-East section) the north-east side, from a point 25 metres north-west of the centre line of Ordsall Road (West to East section) in a south-easterly direction for a distance of 25 metres.
 - (e) West Hill Road, the north-east side, from the centre line of Ordsall Road (West to East section) in a south-easterly direction for a distance of 23 metres.
 - (f) West Hill Road, the south-west side, from a point 20 metres north-west of the centre line of Newlands in a south-easterly direction for 35 metres.
 - (g) Newlands, both sides, from its junction with West Hill Road in a south-westerly direction for a distance of 22 metres.
 - (h) Ollerton Road, the east side, from a point 10 metres north of its junction with Century Road in a southerly direction for a distance of 25 metres.
 - (i) Ollerton Road, the east side, from a point 26 metres south of its junction with Century Road in a southerly direction for a distance of 30 metres.
 - (j) Ollerton Road, the east side, from a point 15 metres north of the centre line of Grace Road in a southerly direction for a distance of 30 metres.
 - (k) Ollerton Road, the west side, from a point 19 metres north of its junction with Ordsall Road in a southerly direction for a distance of 34 metres.
 - (l) Century Road, both sides, from its junction with Ollerton Road in an easterly direction for a distance of 10 metres.
 - (m) Grace Road, both sides, from its junction with Ollerton Road in an easterly direction for a distance of 17 metres.
