

THE NOTTINGHAMSHIRE COUNTY COUNCIL
(A6011 RADCLIFFE ROAD, A6520 RADCLIFFE ROAD AND LADY BAY
BRIDGE, WEST BRIDGFORD AND NOTTINGHAM) (30 MPH SPEED LIMIT)
(RESTRICTED ROAD) ORDER 2021 (8331)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. The length of road specified in the schedules to this Order shall be a restricted road for the purposes of Section 81 of the Act.
2. The following Order is hereby revoked in so far as it relates to the length of road specified in the schedule to this Order.

The Trunk Roads 40 mph Speed Limit (No 1) Order 1982

3. The following Order is to be revoked in whole:

Nottinghamshire County Council (Lady Bay Bridge Road, West Bridgford and Nottingham) (A6011) (40 m.p.h. Speed Limit) Order 1980

4. Any previous speed limit order made under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedule to this Order is hereby revoked.
5. This Order may be cited as "A6011 RADCLIFFE ROAD, A6520 RADCLIFFE ROAD AND LADY BAY BRIDGE, WEST BRIDGFORD and NOTTINGHAM) (30 MPH SPEED LIMIT) (RESTRICTED ROAD) ORDER 2021 (8331)" and shall come into force on xx XXXXXX 2021.

SCHEDULE

A6011 Radcliffe Road, West Bridgford

From a point 22 metres south-east of its junction with Davies Road in north-westerly direction to its junction with Lady Bay Bridge.

A6520 Radcliffe Road, West Bridgford

From its junction with A6011 Radcliffe Road in a south-westerly direction to a point 110 metres west of the centre line of its junction with Edwards Road.

Lady Bay Bridge, West Bridgford and Nottingham

From its junction with A6011 Radcliffe Road in a north-westerly direction to a point 75 metres south east of its junction with Meadow Lane in the city of Nottingham.
