**(50 MPH SPEED LIMIT) ORDER 2021 (3344)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an order under the road traffic regulation act 1984, the effects of which will be, in respects of roads in Budby, Cuckney, Edwinstowe, Norton and Perlethorpe in the Districts of Bassetlaw and Newark and Sherwood: -

No person shall drive any vehicle at a speed exceeding 50 miles per hour on: -

**Length of A616, Budby Road, Cuckney in the District of Bassetlaw**

From a point 20 metres west of its junction with Old Mill Lane in an easterly direction to its junction with Cuckney Road in Perlethorpe cum Budby.

**Length of A616, Cuckney Road in Perlethorpe cum Budby in the District of Newark and Sherwood.**

From its junction with Budby Road, in Norton and Cuckney in an easterly and then a south-easterly direction to its junction with Worksop Road.

**Length of A616, Worksop Road, in Perlethorpe cum Budby in the District of Newark and Sherwood**

- (i) From its junction with Cuckney Road in a south-easterly direction to a point 123 metres north-west of the north-western property boundary of Miklie Cottage.
- (ii) From a point 195 metres south of its junction with Unnamed Road leading to South Farm in a south-easterly direction to its junction with Worksop Road, Edwinstowe

**Length of A616, Worksop Road, in Edwinstowe in the District of Newark and Sherwood.**

From its junction with Worksop Road, Perlethorpe cum Budby in a south-easterly direction to a point 20 metres north-east with its junction with the A614 Ollerton Roundabout.
