

THE NOTTINGHAMSHIRE COUNTY COUNCIL (NEWGATE LANE, MANSFIELD) (PARKING PLACES) TRAFFIC REGULATION ORDER 2019 (2227)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads in Mansfield, in the District of Mansfield: -

1) **PARKING BAYS.** All vehicles – Monday to Saturday, 8am-6.30pm – **1 HOUR PARKING** with No return within 2 hours.

NEWGATE LANE (MANSFIELD)

(the north-west side)

- from a point 120 metres north-east of its junction with Pelham Street in a north-easterly direction for 21 metres.
- from a point 149 metres north-east of its junction with Pelham Street in a north-easterly direction for 17 metres.
- from a point 96 metres south-west of its junction with Gladstone Street in a north-easterly direction for 32 metres.
- from a point 40 metres south-west of its junction with Gladstone Street in a north-easterly direction for 25 metres.
- from a point 4 metres east of its junction with Gladstone Street in an easterly direction for 13 metres.
- from a point 33 metres east of its junction with Gladstone Street in a north-easterly direction for 20 metres.
- from a point 9 metres east of its junction with Hardwick Street in a north-easterly direction for 58 metres.
- from a point 90 metres east of its junction with Hardwick Street in a north-easterly direction to a point opposite the eastern kerbline of King Street.
