VARIOUS ROADS IN BURTON JOYCE – PROPOSED DOUBLE YELLOW LINES (NO WAITING AT ANY TIME) - PUBLIC CONSULTATION – TRO 7254

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce double yellow lines (no waiting at any time) restrictions at various locations in Burton Joyce. The proposed double yellow lines are at the following locations:-

- Chestnut Grove (between Main Street and Church Road (A612)) – along the north-east side of road
- Chestnut Grove (between Church Road (A612) and Lord Nelson PH) – along north-east side of road and outside entrance to play area.
- Junction of Woodsend Close and Main Street
- Junction of Willow Wong and Mayfield Avenue
- Junction of Mayfield Avenue and Willow Close
- Junction of Farnsfield Avenue and Church Road (A612)
- Junction of Shelford Crescent and Church Road (A612)

The double yellow lines at the junctions are intended to keep the junctions clear of parked vehicles to give better visibility for drivers turning into or out of them. The lines will also help ensure that pedestrians have an unobstructed route across the road. On Chestnut Grove (between Main Street and Church Road) the restrictions are to keep one side of the road clear to give better access for vehicles turning in or out of the Co-op car park, especially delivery vehicles. On the southern section of Chestnut Grove the removal of parked vehicles from one side of the road will help ensure that delivery vehicles can access the Lord Nelson public house. On the opposite side of the road the restrictions will keep the pedestrian entrance into the play area clear for safer access.

The proposals will be advertised and notices displayed on site. Plans showing the proposals (drawing numbers H/JAB/3931/01 to 06) are attached along with a copy of the site notice.

Before proceeding further with the proposed double yellow lines, I wish to consider the views of residents and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me by **25th April 2022**.
