

## The Nottinghamshire County Council (Various Roads in Burton Joyce)(Prohibition of Waiting) Traffic Regulation Order 2022 (7254)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Burton Joyce in the Borough of Gedling:-

1. Proposed No waiting at any time restrictions (double yellow lines) at the following locations:-

- (i) CHESTNUT GROVE (the north-east side)
  - from a point 10 metres south-east of its junction with Main Street in a south-easterly direction to a point 10 metres north-west of its junction with Church Road.
- (ii) from a point 26m south-east of its junction with Church Road in a south-easterly direction for 44m.
- (iii) CHESTNUT GROVE (the south-west side)
- from a point 14m south-east of its junction with Church Road in south-easterly direction for 15m.
- (iv) <u>CHURCH ROAD (the north-west side)</u> from a point 12 metres south-west of its junction with Farnsfield Avenue in a north-easterly direction to a point 10 metres north-east of the same junction.
- (v) from a point 10 metres south-west of its junction with Shelford Crescent in a north-easterly direction to a point 10 metres north-east of the same junction.
- (vi) **FARNSFIELD AVENUE** (both sides)
- from its junction with Church Road in a north-westerly direction for 10 metres.
- (vii) <u>MAIN STREET (the north-west side)</u> from a point 10 metres south-west of its junction with Woodsend Close in a north-easterly direction to a point 10 metres north-east of the same junction.
- (viii) **MAYFIELD AVENUE** (the north-west side)
- from its junction with Willow Wong in a north-easterly direction for 10 metres.
- (ix) from a point 12 metres south-west of its junction with Willow Close in a north-easterly direction to a point 10 metres north-east of the same junction.
- (x) MAYFIELD AVENUE (both sides)
- from its junction with Willow Wong in a north-easterly direction for 10 metres.
- (xi) SHELFORD CRESCENT (both sides)
- from its junction with Church Road in a north-westerly direction for 10 metres.
- (xii) WILLOW CLOSE (the north-east side)
- from its junction with Mayfield Avenue in a north-westerly direction for 10 metres.
- (xiii) WILLOW CLOSE (the south-west side)
- from its junction with Mayfield Avenue in a north-westerly direction for 12 metres.
- (xiv) <u>WILLOW WONG (the north-east side)</u> from a point 10 metres north-west of its junction with Mayfield Avenue in a south-easterly direction to a point 10 metres south-east of the same junction.
- (xv) WOODSEND CLOSE (both sides)

from its junction with Main Street in a north-westerly direction for 10 metres.

The double yellow lines are being introduced to remove parked vehicles from various junctions in Burton Joyce to give better visibility for vehicles turning in or out. Other double yellow lines are to improve access to the Co-op car park and the Lord Nelson public house, especially for delivery vehicles. The restrictions will remove parked vehicles from outside the pedestrian entrance to the play area on Chestnut Grove.
