

<u>The Nottinghamshire County Council (Featherstone Close, Kings Mill Lane,</u> <u>Millersdale Avenue and Randol Close, Mansfield) Prohibition of Waiting) and</u> (Parking Places) Traffic Regulation Order 2021 (2248)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Mansfield in the District of Mansfield: -

1. Vehicles will be prohibited from Waiting At Any Time along the following lengths of road:

Featherstone Close, Mansfield (the north-east side)

• From its junction with Kings Mill Lane in a north-easterly direction for 12 metres

Featherstone Close, Mansfield (the south-east side)

• From its junction with Kings Mill Lane in a north-easterly direction for 11 metres

Kings Mill Lane, Mansfield (the north-east side)

- From its junction with Millersdale Avenue in a southerly direction for 10 metres.
- From a point 10 metres north-west of its junction with Featherstone Close in a southeasterly direction to a point 6 metres south of its junction with Randol Close.

Kings Mill Lane, Mansfield (the south-west side)

• From a point opposite the northern kerbline of Randol Close in a southerly direction for 10 metres.

Millersdale Avenue, Mansfield (the north-east side)

• From its junction with Kings Mill Lane in a north-easterly direction for 15 metres.

Millersdale Avenue, Mansfield (the south-westside)

• From its junction with Kings Mill Lane in a north-easterly direction for 14 metres.

Randol Close, Mansfield (the north side)

• From its junction with Kings Mill Lane in an easterly direction for 11 metres.

Randol Close, Mansfield (the south side)

- From its junction with Windmill Lane in a north-westerly direction for 14 metres.
 - 2. To provide 2 hours parking, no return within 1 hour along the following length of road: -

Kings Mill Lane, Mansfield (the east side)

• From a point opposite the northern kerbline of Randol Close in a north-westerly direction for 73 metres.
