

**The Nottinghamshire County Council**  
**(Enderby Gardens, Henry Street Larkspur Avenue, and Monsell Drive, Redhill and Leivers Avenue, Arnold.) (Prohibition of Waiting and Residents Controlled Zone) Traffic Regulation Order 2019 (7217)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads in Arnold in the District of Gedling: -

1. To provide residents' parking places operating Monday to Saturday 8am to 6pm along Leivers Avenue, Arnold
2. Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

**ENDERBY GARDENS, REDHILL** (both sides)

- from its junction with Monsell Drive in a north-easterly direction for 10 metres.

**HENRY STREET, REDHILL** (north-east side)

- from its junction with Mansfield Road in a north-westerly direction for 17 metres.

**HENRY STREET, REDHILL** (south-west side)

- from its junction with Mansfield Road in a north-westerly direction for 37 metres.

**LARKSPUR AVENUE, REDHILL** (north-east side)

- from its junction with Mansfield Road in a north-westerly direction for 32 metres.

**LARKSPUR AVENUE, REDHILL** (south-west side)

- from its junction with Mansfield Road in a westerly and then north-westerly direction for 33 metres.

**MONSELL DRIVE, REDHILL** (north side)

- from its junction with Mansfield Road in an easterly direction for 34 metres.

**MONSELL DRIVE, REDHILL** (south side)

- from its junction with Mansfield Road in an easterly direction for 32 metres.

3. Vehicles will be prohibited from **waiting Mon-Sat 8am- 6pm** along the following length of road.

**LEIVERS AVENUE, ARNOLD** (the west side)

- from a point 12 metres south-west of its junction with Runswick Drive in a south-westerly direction for 6 metres.
