

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ASHLEY ROAD, CHURCH DRIVE, WALTON DRIVE AND WOLDS DRIVE, KEYWORTH.) (PROHIBITION OF WAITING AND NO STOPPING ON ENTRANCE CLEARWAYS) TRAFFIC REGULATION ORDER 2019 (8292)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Keyworth in the Borough of Rushcliffe: -

1. Vehicles will be prohibited from waiting at any time along the following: -

ASHLEY ROAD, KEYWORTH (west side)

• from a point 10 metres north of its junction with Church Drive in a southerly direction to a point 10 metres south of that junction.

ASHLEY ROAD, KEYWORTH (east side)

• from a point 10 metres north of its junction with Church Drive in a southerly direction to a point 10 metres south of that junction.

CHURCH DRIVE, KEYWORTH (north side)

- from a point 10 metres west of its junction with Ashley Road in an easterly direction to a point 10 metres east of that junction.
- from a point 11 metres west of its junction with Walton Drive in an easterly direction to a point 15 metres east of that junction.
- from its junction with Wolds Drive in a south-westerly direction for 15 metres.

CHURCH DRIVE, KEYWORTH (south side)

- from a point 10 metres west of its junction with Ashley Road in an easterly direction to a point 14 metres east of that junction.
- from a point 55 metres south west of its junction with Wolds Drive in a westerly direction for 24 metres.
- from its junction with Wolds Drive in a south-westerly direction for 15 metres.

WALTON DRIVE, KEYWORTH (both sides)

• from its junction with Church Drive in a northerly direction for 10 metres.

WOLDS DRIVE, KEYWORTH (west side)

• from a point 10 metres north west of its junction with Church Drive in a southerly direction to a point 18 metres south of that junction.

2. Vehicles will be prohibited from stopping on school entrance markings on Monday to Friday between 8am and 4.30pm along the following: -

CHURCH DRIVE, KEYWORTH (south side)

- from a point 45 metres south west of its junction with Wolds Drive in a south westerly direction for 25 metres.
- from a point 23 metres opposite Walton Drive (east side kerbline) in a south easterly direction for 25 metres.
