

# The Nottinghamshire County Council (Beacon Hill Road, Magdalene View, Side Row and Stanley Terrace, Newark) (Prohibition of Waiting) Traffic Regulation Order 2020 (3316)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Newark in the District of Newark and Sherwood: -

Vehicles will be prohibited from Waiting At Any Time along the following length of road: -

#### Beacon Hill Road, Newark

• from a point 5 metres west of its junction with Magdalene View in an easterly direction to a point 5 metres east of that junction.

## Magdalene View, Newark (the east side)

 from its junction with Beacon Hill Road in a southerly direction to a point 15 metres south-east of its junction with Side Row.

### <u>Magdalene View, Newark</u> (the west side)

 from its junction with Beacon Hill Road in a southerly direction to a point 12 metres south-east of its junction with Stanley Terrace.

#### **Side Row, Newark** (the north side)

from its junction with Magdalene View in an easterly direction for 12 metres

#### Side Row, Newark (the south side)

from its junction with Magdalene View in an easterly direction for 14 metres

## Stanley Terrace, Newark (the north side)

from its junction with Magdalene View in a westerly direction for 9 metres

## **Stanley Terrace, Newark** (the south side)

from its junction with Magdalene View in a westerly direction for 7 metres

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall libraries are closed or if reopened will have restrictions in place.
