

<u>The Nottinghamshire County Council (Bluebell Wood Way, Grange Farm Close and The</u> <u>Dumbles, Sutton-in-Ashfield) (Prohibition of Waiting) Traffic Regulation Order 2019 (4246)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton-in-Ashfield in the District of Ashfield:-

Vehicles will be prohibited from waiting at any time along the following lengths of road: -

- 1. <u>BLUEBELL WOOD WAY, SUTTON-IN-ASHFIELD</u> (the north-west side)
- From its junction with Woodlands Way in a south-westerly direction for 24 metres.
- From a point 10 metres north-east of its junction with The Dumbles in a south-westerly direction to a point 9 metres south-west of that junction.
- From its south-western extremity in a north-easterly direction for 6 metres.
- 2. <u>BLUEBELL WOOD WAY, SUTTON-IN-ASHFIELD</u> (the south-east side)
- From its junction with Twinyards Close in a south-westerly direction to its southern extremity (including the turning head).
- 3. <u>GRANGE FARM CLOSE, SUTTON-IN-ASHFIELD</u> (both sides)
- From its junction with Bluebell Wood Way in a south-easterly direction for 13 metres.
- 4. <u>THE DUMBLES, SUTTON-IN-ASHFIELD</u> (the north-east side)
- From its junction with Bluebell Wood Way in a north-westerly direction for 8 metres.
- 5. <u>THE DUMBLES, SUTTON-IN-ASHFIELD</u> (the south-west side)
- From its junction with Bluebell Wood Way in a north-westerly direction for 10 metres.
