

**The Nottinghamshire County Council (Burton Road, Orlando Drive,  
Ousebridge Drive and Willow Road, Carlton, Nottingham)  
(Prohibition of Waiting) Traffic Regulation Order 2019 (7213)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Carlton in the Borough of Gedling: -

Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

**BURTON ROAD, CARLTON** (east side)

- From a point 11 metres north-east of its junction with Ousebridge Drive in a south-westerly direction to a point 11 metres south-west of that junction.
- From a point 10 metres north-east of its junction with Willow Road in a south-westerly direction to a point 9 metres south-west of that junction.

**BURTON ROAD, CARLTON** (west side)

- From a point 13 metres north east of its junction with Orlando Drive in a south-westerly direction to a point 10 metres south-west of that junction.

**ORLANDO DRIVE, CARLTON** (north side)

- From its junction with Burton Road in a north-westerly direction for 10 metres.

**ORLANDO DRIVE, CARLTON** (south side)

- From its junction with Burton Road in a north-westerly direction for 11 metres.

**OUSEBRIDGE DRIVE, CARLTON** (north side)

- From its junction with Burton Road in an easterly direction for 10 metres.

**OUSEBRIDGE DRIVE, CARLTON** (south side)

- From its junction with Burton Road in an easterly direction for 13 metres.

**WILLOW ROAD, CARLTON** (both sides)

- From its junction with Burton Road in an easterly direction for 10 metres.
