

**The Nottinghamshire County Council (Windmill Lane Area, Mansfield)
(Parking Places and Residents' Controlled Zone) and (Prohibition of
Waiting) Traffic Regulation Order 2021 (2240)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Mansfield in the District of Mansfield: -

1. Vehicles will be prohibited from **Waiting At Any** Time along the following lengths of road:

CLIPSTONE AVENUE, MANSFIELD (the north-east side)

- from its junction with Park Avenue in a south-easterly direction for 10 metres.
- from a point 50 metres south-east of its junction with Park Avenue in a south-easterly direction for 16 metres.
- from its junction with Windmill Lane in a north-westerly direction for 10 metres.

CLIPSTONE AVENUE, MANSFIELD (the south-west side)

- from its junction with Park Avenue in a south-easterly direction for 10 metres.
- from a point 50 metres south-east of its junction with Park Avenue in a south-easterly direction for 30 metres.
- from its junction with Windmill Lane in a north-westerly direction for 10 metres.

OAK AVENUE, MANSFIELD (both sides)

- from its junction with Windmill Lane in a north-westerly direction for 10 metres.

PARK AVENUE, MANSFIELD (the south-east side)

- from a point 10 metres north-east of its junction with Clipstone Avenue in a south-westerly direction to a point 10 metres south-west of that junction.

SUNNYCROFT COURT, MANSFIELD

(the north-east side)

- from its junction with The Park in a south-easterly direction for 10 metres.

SUNNYCROFT COURT, MANSFIELD

(the south-west side)

- from its junction with The Park in a south-easterly direction for 10 metres.

THE PARK, MANSFIELD (the north-west side)

- from a point opposite a point 4 metres south-west of the south-western kerbline of Sunnycroft Court in a north-easterly then north-westerly direction for 27 metres.

THE PARK, MANSFIELD (the south-east side)

- from a point 10 metres south-west of its junction with Sunnycroft Court in a north-easterly direction to a point 3 metres north-east of that junction.

WINDMILL LANE, MANSFIELD (the north-west side)

- from its junction with The Park in a south-westerly direction for 106 metres.
- from a point 10 metres north-east of its junction with Oak Avenue in a south-westerly direction to a point 10 metres south-east of that junction.

WINDMILL LANE, MANSFIELD (the south-east side)

- from a point opposite the northern boundary of "Carbis" in a north-easterly direction to its junction with The Park

WATSON AVENUE, MANSFIELD (the south-east side)

- from a point 106 metres north-east of its junction with Bath Lane in a north-easterly direction for 6 metres
2. Vehicles will be prohibited from **Waiting between Mon-Fri, 8am- 4.30pm** along the following length of road:

SUNNYCROFT COURT, MANSFIELD (the north-east side)

- from a point 10 metres south-east of its junction with The Park in south-easterly then a south-westerly direction to its south-eastern extremity (including the turning head.)

SUNNYCROFT COURT, MANSFIELD (the south-west side)

- from a point 35 metres south-east of its junction with The Park in a north-easterly then south-easterly direction to its extremity

3. To provide 3 hours parking, no return within 1 hour. Operating Monday to Saturday 8am – 6pm along the following length of road: -

BATH LANE (MANSFIELD) (north-east side)

- from a point 94 metres north-east of its junction with Shirburn Avenue in a north-easterly direction for 36 metres.
- from a point 136 metres north-east of its junction with Shirburn Avenue in a north-easterly direction for 74 metres.

4. Residents Parking Area on the following road –

WATSON AVENUE, MANSFIELD (south-east side)

- from a point 88 metres north of its junction with Bath Lane in a northerly direction for 18 metres.
- from a point 112 metres north of its junction with Bath Lane in a northerly direction for 8 metres.
