

The Nottinghamshire County Council (Branston Avenue and Ridgeway Close, Farnsfield) (Prohibition of Waiting) Traffic Regulation Order 2021 (3324)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Farnsfield in the District of Newark and Sherwood: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

<u>Branston Avenue, Farnsfield</u> (the north-west side)

• from a point 10 metres north-east of its junction with Ridgeway Close in a south-westerly direction to a point 10 metres south-west of that junction.

<u>Branston Avenue, Farnsfield</u> (the south-east side)

 from a point 12 metres north-east of its junction with Ridgeway Close in a south-westerly direction to a point 10 metres south-west of that junction.

Ridgeway Close, Farnsfield (the north side)

• from a point 10 metres north-west of its junction with Branston Avenue in a south-easterly direction to a point 10 metres south-east of that junction.

Ridgeway Close, Farnsfield (the south side)

- from a point 10 metres north-west of its junction with Branston Avenue in a south-easterly direction to a point 10 metres south-east of that junction.
- from a point 11 metres west of its junction with Ridgeway Cul-de-sac in a south-easterly direction to a point 13 metres south-east of that junction.

Ridgeway Close, Farnsfield (Cul- de- sac adjacent to no's 29-31) (the east side)

from its junction with Ridgeway Close in a south-westerly direction for 12 metres

Ridgeway Close, Farnsfield (Cul- de- sac adjacent to no's 29-31) (the west side)

from its junction with Ridgeway Close in a south-westerly direction for 12 metres

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall and Libraries are closed or if reopened will have restrictions in place.
