

<u>The Nottinghamshire County Council (Central Avenue Area, Beeston)</u> <u>(Prohibition of Waiting) Traffic Regulation Order 2021 (5300)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Beeston in the Borough of Broxtowe: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

<u>Abbey Road, Beeston</u> (the north-west side)

From a point 12 metres north-east of its junction with Firs Avenue in a south-westerly direction to a
point 10 metres south-west of that junction.

Alderman Close, Beeston (the north side)

From its junction with Central Avenue in a north – easterly direction for 12 metres.

<u>Alderman Close, Beeston</u> (the south side)

• From its junction with Central Avenue in a north – easterly direction for 12 metres.

Boundary Road, Beeston (the south-west side)

From a point 11 metres north-west of its junction with Brook Road in a south-easterly direction to a
point 11 metres south-east of that junction.

Brook Road, Beeston (the north - west side)

From its junction with Boundary Road in a south – westerly direction for 11 metres

Brook Road, Beeston (the south- east side)

• from its junction with Boundary Road in a south – westerly direction for 11 metres

Central Avenue, Beeston (the east side)

- From a point 10 metres north of its junction with Alderman Close in a southerly direction to a point 12 metres south of that junction.
- From a point 10 metres north of its junction with Wallet Avenue in a southerly direction to a point 12 metres south of that junction

Central Avenue, **Beeston** (the west side)

• From a point 11 metres north-west of its junction with Dennis Avenue in a south-easterly direction to a point 11 metres south of that junction

Dennis Avenue, Beeston (the north side)

From its junction with Central Avenue in a westerly direction for 11 metres

Dennis Avenue, Beeston (the south side)

• From its junction with Central Avenue in a westerly direction for 13 metres

Wallett Avenue, Beeston (the north side)

• From its junction with Central Avenue in a south-easterly direction for 47 metres

Wallett Avenue, Beeston (the south side)

• From its junction with Central Avenue in a south-easterly direction for 12 metres
